International applicants who are eligible for enrollment in the Graduate School of Environmental Studies with student visa status can apply for the “Special application for international students”. This brochure is a simple version of the guidelines for such applicants. More detailed information is provided in the Japanese version. Students whose mother tongue is not Japanese are recommended to contact their prospective supervisor to obtain more detailed information.

## I. MASTER’S DEGREE PROGRAM

### 1. Eligibility Requirements

Applicants must meet one of the requirements listed below:

- (1) Graduation, or expected graduation by March 31, 2022 from an undergraduate school or university in Japan.
- (2) Completion, or expected completion by March 31, 2022, of 16 years of formal education in his/her home country or other countries.
- (3) Persons who have been conferred, or expect to be conferred by March 31, 2022, a degree equivalent to a bachelor’s degree through attending an overseas university or another overseas school (limited to those whose education and research activities have been evaluated by persons who have been certified by the relevant country’s government or a related institution, or have been separately designated by the Minister of Education, Culture, Sports, Science and Technology as being equivalent to such) and graduated from a program that requires 3 or more years to complete (includes graduating from a program implemented by the relevant overseas school while living in Japan through distance learning, as well as graduating from a program implemented by an educational facility established with the relevant overseas country’s school education system and has received the designation mentioned above).
- (4) Approved by the Minister of Education, Culture, Sports, Science and Technology of Japan (MEXT) (1953 Ministry Bulletin, Vol. 5).
- (5) Have completed 3 years (or above) of education at a university in Japan, or have completed 15 years of formal education at an institution overseas; Or, have completed 15 years of formal education at an overseas institution in Japan (provided the program is equivalent to the formal education in its foreign country and is being recognized by the Japanese Minister of Education, Culture, Sports, Science and Technology) by March 31, 2022. The applicant should also have earned all credits in good academic standing. All mentioned above should be recognized by the Graduate School of Environmental Studies.
- (6) Completion of a program of study recognized by the Graduate School of Environmental Studies as equivalent to graduation from a Japanese university.

**Note:** Applicants wishing to apply based on the requirement (5) or (6) above will be given an eligibility examination. Please contact the Office of Student Affairs at the Graduate School of Environmental Studies for details. A separate application is required for the eligibility examination, to be submitted by June 9, 2021.

## 2. Departments Offering Master's Degree Programs

Departments offering a Master's Program at the Graduate School of Environmental Studies are as follows:

- Department of Earth and Environmental Sciences
- Department of Environmental Engineering and Architecture
- Department of Social and Human Environment

## 3. Application Procedures

Applicants must prepare the following documents and submit them by registered mail to: The Office of Student Affairs, Graduate School of Environmental Studies, Nagoya University, D2-1(510), Furo-cho, Chikusa-ku, Nagoya 464-8601, Japan.

The application documents must reach the Office of Student Affairs between July 5 and 4:00 p.m. July 9, 2021. (Only applications submitted by registered mail are acceptable.)

All application documents shall be filled out in either Japanese or English.

The application fee must be paid through the information terminal at the convenience store in Japan, following the directions in Appendix 1. Only overseas applicants are allowed to make payment by credit card, UnionPay, and Alipay. Please refer to Appendix 2 for payment procedures in detail. Applicants must complete the payment process on the website (<https://e-shiharai.net/english/>) by July 8, 2021, before submitting the application documents.

### DOCUMENTS REQUIRED:

- (1) Application Form
- (2) Examinee's Registration Card, Photograph Card (affix a photograph (4×3 cm) taken within the last 3 months)
- (3) Curriculum Vitae/Resume
- (4) Reason for Application
- (5) \*Official Transcript (or Academic Record) from the university above (originals only; photocopies are not acceptable. English version is required if the transcript is written neither in Japanese nor in English).
- (6) \*Diploma or Certificate of Graduation or Expected Graduation from the university where the applicant pursued undergraduate studies (originals only; photocopies are not acceptable. An English version is required if the certificate is written neither in Japanese nor in English).  
\*(5)(6) Note: For applicants who have graduated from a university in the People's Republic of China: We reserve the right to investigate applicants' credentials, for example the Degree Certificate or Expected Graduation Certificate, or the academic transcript submitted by an applicant through the China Academic Degrees and Graduate Education Development Center (CDGDC).
- (7) Application fee (30,000 yen) \*<sup>1</sup>  
Please refer to the "3. Application Procedures".  
Enclose the printed "Result" page in an application envelope with other necessary application documents.
- (8) Name and Address Card
- (9) TOEFL/TOEIC/IELTS original score sheet (Required only for applicants to the Department of Earth and Environmental Sciences, the Department of Environmental Engineering and Architecture, and applicants for self-recommendation admission to the Department of Social and Human Environment)  
Applicants must submit an original score sheet of the "Test Taker Score Report" of TOEFL (iBT)", the

“Official Score Certificate” of TOEIC (Listening & Reading test), or the “Test Report Form” of IELTS (Academic Module). Only scores of the examinations taken on or after August 1, 2019, will be accepted. The original score sheet will not be returned. For more details, please refer to the “4. Examination Method”. In case of applicants for self-recommendation admission to the Department of Social and Human Environment, however, graduates and soon-to-be graduates from an institution of higher education whose language of instruction is English do not need to submit a TOEFL/TOEIC/IELTS original score sheet.

(10) Self-Recommendation Letter (Required for applicants for self-recommendation admission to the Department of Earth and Environmental Sciences, the Architecture Course at the Department of Environmental Engineering and Architecture and the Department of Social and Human Environment)  
Only applicants for self-recommendation admission to the above Departments must write a self-recommendation letter.

(11) Additional Application Form

Applicants to the Department of Earth and Environmental Sciences must fill out this form.

(12) Essay (required only for applicants to the Sustainable Development Course in the Department of Environmental Engineering and Architecture)

International applicants to the Sustainable Development Course in the Department of Environmental Engineering and Architecture must submit an essay entitled “SDGs and me” as part of their application. The typewritten essay on a computer (A handwritten essay will not be accepted) should be no more than 500 words (or 1000 characters in Japanese) and printed on single-sided A4 paper (maximum 2 pages). There are no other formatting requirements. Note that it must be original and unpublished.

(13) List of publications, awards and achievements (applicants to the Sustainable Development Course in the Department of Environmental Engineering and Architecture only)

International applicants to the Sustainable Development Course in the Department of Environmental Engineering and Architecture must submit a list of publications, awards and achievements as part of their application. Prepare and print the document on single-sided A4 paper. There are no other formatting or page requirements. If there are no applicable items, submit a paper noting this.

(14) Research Proposal (applicants to the Department of Social and Human Environment only)

There is no specific format or page requirement. Print the document on A4 paper. It must include the following: 1) background of the problem and research objectives, 2) a review of existing literature, and 3) research methodology and methods. The proposal should refer to the relevant literature where appropriate. It should be written in either Japanese or English.

(15) A photocopy of your residence card

Applicants who are currently residing in Japan must submit a photocopy of their residence card (both sides).

(16) Applicants receiving a scholarship from the Japanese Government (MEXT) must provide a Certificate of Status issued by the university where they are currently enrolled. However, applicants who are presently enrolled in Nagoya University do not need to do it.

## 4. Examination Method

### (1) Department of Earth and Environmental Sciences

The Department of Earth and Environmental Sciences consists of the Division of Earth and Planetary Sciences and the Division of Hydrospheric-Atmospheric Sciences. The Division of Earth and Planetary Sciences consists of the following seven laboratories: Earth Environmental Systems, Geology and Geobiology, Geochemistry and Cosmochemistry, Earth and Planetary Physics, Ecology, Earth and Planetary Dynamics, and Chronology and Natural History. The Division of Hydrospheric-Atmospheric Sciences consists of the following four laboratories: Global Environmental Variation, Climate Science, Global Geochemistry, and Global Water Cycle.

Applicants are required to contact their prospective supervisor(s) prior to application. This ensures that the supervisor(s) can prepare for the examination by taking the applicants' language ability and academic background into consideration.

Please refer to the "DOCUMENTS REQUIRED" regarding the "English Test".

The original TOEFL/TOEIC/IELTS score sheet taken on or after August 1, 2019, will be converted into the score for the test subject "English". Documents other than those listed above (e.g. TOEIC-IP test) will not be accepted. If a valid score sheet is not submitted, the score for the examination subject "English" will be zero.

#### **【Division of Earth and Planetary Sciences】**

##### 1. General Selection

The applicant's academic abilities will be assessed at a regular entrance examination (English, specialized subjects, and oral examination). The score for the English portion will be calculated by converting the score listed on the TOEFL/TOEIC/IELTS score sheet submitted by the applicant. Applicants to the Department of Earth and Planetary Sciences may take both the regular entrance examination and the self-recommendation entrance examination. Those applying for the self-recommendation entrance examination must submit a Self-recommendation Form (prescribed by the Graduate School).

The written and oral examinations will be conducted online via web conferencing system. The written examination can be also taken face-to-face at an examination site prepared by Nagoya University. Please select your preferred examination method for the written examination on the Additional Application Form. However, please note that if the university is unable to prepare the examination site due to a worsening of the coronavirus situation, all examinations will be conducted online.

Detailed information about the examination process will be sent to each applicant by e-mail, after the application is submitted.

The following table shows the examination schedule.

\*1: Applicants will be questioned on fundamental aspects of their academic field, taking the applicants' language ability and academic background into consideration. The examination will be conducted either in Japanese or English as appropriate for the applicants' language ability.

\*2: Applicants will be asked to answer questions about their undergraduate research and general research interests in English and/or Japanese.

\*3: This interview will be conducted to evaluate the English proficiency of the applicants if the oral examination is conducted in Japanese. The interview consists of questions about the applicants' motivation for applying and their research plans after enrollment.

[How to submit score sheets]

The score sheet must be submitted to the Office of Student Affairs in the same manner as described in "3. Application Procedures", and must arrive no later than August 17, 2021 (Tuesday). If the score sheet is ready at the time of application, it may be enclosed in the envelope containing the necessary documents, and submitted to the Office.

[Examination site]

Written examination: A place where you can be held in a quiet environment and where you will not be suspected of cheating on the examination (online examination), or an examination site at Nagoya University (face-to-face examination). Applicants are required to specify whether they wish to take the online or face-to-face examination on the additional application form and send it at the time of application.

However, if the university's examination site cannot be prepared due to the worsening of the corona infection situation, all examinations will be conducted online.

Oral examination: A place where you can be held in a quiet environment and where you will not be suspected of cheating on the examination.

### **【Division of Hydrospheric-Atmospheric Sciences】**

The scholastic ability test is conducted by the regular entrance examination (English, specialized subjects, and oral examination) or the Self-Recommendation entrance examination (English and oral examination) for students who are not from science-related departments. Regarding the "English Test", please refer to the 3. Application Procedures, DOCUMENTS REQUIRED. The original TOEFL/TOEIC/IELTS score sheet taken on or after August 1, 2019, will be converted into the score for the test subject "English". Documents other than those listed above (e.g. TOEIC-IP test) will not be accepted. If a valid score sheet is not submitted, the score for the examination subject "English" will be zero. Applicants who are unable to prepare a valid TOEFL/TOEIC/IELTS score sheet by the designated time may apply for the special English examination conducted by the Graduate School (Division of Hydrospheric-Atmospheric Sciences) by filling in the necessary information on the "Additional Application Form (Division of Hydrospheric-Atmospheric Sciences)". Applicants who can prepare a valid TOEFL/TOEIC/IELTS score sheet by the designated time should not take the special English examination.

Applicants who take the Self-Recommendation entrance examination must submit the Self-Recommendation Form (a form of the Graduate School).

Following Nagoya University's action guidelines for the new coronavirus infection (COVID-19), the special English exam may be canceled and all oral examinations may be changed to remote (online) examinations. In addition, the online examinations may be held at times other than those listed below.

It is recommended to contact your prospective advisor in advance regarding your desired research theme.

The following table shows the examination schedule and venue. Oral examinations will be conducted in the Environmental Studies Hall. Applicants should arrive 10 minutes prior to the start of the examination and wait until called.

- \*1: Only applicants who fill out and submit the Additional Application Form (Division of Hydrospheric-Atmospheric Sciences) and are approved may take the examination. Those who cannot come to the campus on the day of the special examination cannot take this exam. The TOEFL ITP provided by the Educational Testing Service will be used.
- \*2: The specialization subject examination (about 30 minutes) will be conducted during the specified time as a remote (online) examination via the internet. Please fill out and submit the Additional Application Form (Division of Hydrospheric-Atmospheric Science). Applicants will be contacted between July 14 and July 23 by a faculty member of the field you wish to apply to in order to schedule the specialization subject examination and discuss details about the online remote examination.
- \*3: The original TOEFL/TOEIC/IELTS score sheet must be prepared and presented as instructed during the examination, except for those who enclose the score sheet with the application form and those who take the special English examination. In addition, an oral examination may be held during the specialization subject examination to assess the examinee's English ability.
- \*4: If it is difficult to come to Nagoya University, the option for remote (online) examination may be selected. Applicants who wish to take the online examination should fill out and submit the Additional Application Form (Division of Hydrospheric-Atmospheric Sciences). Applicants who wish to take the online examination will be notified of the availability of the online examination and its details, designated date/time of the oral examination when the exam voucher is sent. Applicants will be asked to answer questions in English and/or Japanese about their undergraduate research, their motivation for applying, and their research plans after enrollment.

**Submission for score sheet of English test:** For the submission of the score sheet, fill in the appropriate sections of the "Additional Admission Application Form (Division of Hydrospheric-Atmospheric Sciences)". If you can prepare a valid TOEFL/TOEIC/IELTS score sheet at the time of application, submit it to the Graduate School together with the Application Form. If you are unable to prepare the score sheets at the time of application, but are able to prepare the score sheets by the day of the professional examination or the oral examination for the Self-Recommendation examination, you may present the original score sheet at the time of those examinations. In such a case, the original score sheet must be submitted to the Graduate School in the same manner as described in "3. Application Procedures", with "Score Sheet Enclosed" written in red on the front of the envelope, no later than Wednesday, August 25, 2021.

## (2) Department of Environmental Engineering and Architecture

### Important Notices on the submission of the TOEFL/TOEIC/IELTS score sheet

(Only for applicants to the Department of Environmental Engineering and Architecture):

- As described in the “DOCUMENTS REQUIRED” section, submission of the score sheet at the time of application is strongly recommended, but (re-)submission on the day of the exam is acceptable. In this case, the score sheet should be sent before the designated deadline notified to an applicant.
- Original scores of TOEFL iBT “Home edition” test will also be accepted as a special measure in the entrance examination according to this application guideline. In this case, submit it with a pledge signed by the applicant.

### (2.1) Sustainable Development Course

[Important Notices]

- Applicants should contact their prospective supervisor in advance. The questions in the examination are likely to take the applicants’ language ability and academic background into consideration.
- Applicants must submit an essay entitled “SDGs and me” and a list of publications/awards/achievements as part of their application. Refer to the DOCUMENTS REQUIRED section for details.

#### ① General information

Examinations for international students will be held according to Examination Schedule A.

#### ② Examinations and schedule

The schedule of examinations is shown in the following table. Examinations will be conducted in English and/or Japanese. Regarding the “English Test”, refer to the “DOCUMENTS REQUIRED” section in “3. Application Procedures” and to footnote 3 (\*3) in the following Table.

\*1: For each examinee, an oral examination of about 30 minutes will be conducted online using Zoom. The admissions staff will email the details, such as exam schedule and method, to you by July 30th.

\*2: Applicants will be asked to select three questions from the following two categories: (1) Environmental Engineering and Policy (up to three questions) and (2) Environmental Chemistry (up to two questions). Refer to the 受験案内 (Entrance Exam Guide in the Japanese version) in the separate file for the range of questions.

\*3: TOEIC/TOEFL/IELTS English score sheet: Examinees who wish to (re-)submit a score sheet on the day of the examination must inform the person in charge by the day before the examination. The admission staff or prospective supervisor will instruct the applicant of the details for submission, including the deadline. If the original score sheet is already available when an applicant sends the application documents, it is preferable to enclose and send it in advance.



## (2.2) Architecture Course

### ① General information

Examinations for international students will be held according to Examination Schedule B. Applicants are required to submit the additional documents on the desired research theme and content after submission of the application form.

### ② Examinations and schedule

The schedule of examinations is shown in the following table. Japanese language should be used in the examinations.

**Applicants should contact their prospective supervisor before application,** as the examination may take into account the applicants' language skills.

\*1: The "Oral Examination" will be held on August 19th using an online meeting system such as Microsoft Teams or Zoom. In this examination, applicants are requested to answer questions in Japanese about the contents of the submitted documents and one of the three fields of architecture: (1) planning (design, planning and history), (2) environmental engineering (environment and building services), and (3) structural engineering (structures and materials). Applicants should prepare a device such as a computer or a tablet that can communicate with video and audio, as well as a network environment that allows online "Oral Examination" in a place where others are not present (such as a private room at home).

\*2: The official score sheet of the TOEFL/TOEIC/IELTS should be shown in the examination in the case of no submission at the time of application nor resubmission on the day of examination. In this case, the score sheet should be sent to the school by the designated deadline notified to an applicant.

\*3: Applicants are requested to answer questions mainly relating to their motivations, learning and research plans after admission, and related topics (in Japanese). The schedule for the "Interview" may be altered due to the number of applicants. If it is changed, details will be announced before the "Interview".

\*4: The location to connect will be announced before the examination.

### (3) Department of Social and Human Environment

The entrance examination is scheduled as below. Please make sure to consult your prospective supervisor(s) prior to application, because examination questions may be prepared according to your language skills and academic background.

\*1 The oral examination will be held during the designated date/time above. After applying, each applicant will be notified of the designated date and time and other details of the oral examination.

In the oral examination, you will be required to answer questions regarding a number of topics, including your previous research, your research proposal, and specialized knowledge in your chosen academic field. See below for the range of specialized knowledge questions in each academic field.

\*1 International student applicants can also apply for “General application (Regular admission)” the same as domestic applicants (please see the Japanese version of the application guideline for details).

Applicants who wish to take the “self-recommendation admission” must get prior approval from their prospective supervisor by the time the application documents are submitted.

Accordingly, applicants must consult with their prospective supervisor well before the date.

(Please note that applications are approved only in limited circumstances for those with high academic potential and achievement. Dual application to “special application for international students” and “general

application”, including “self-recommendation admission”, is not allowed.) Applicants must mention the name of their prospective supervisor who approved their application on the application form.

\*2 After applying, each applicant will be notified of the designated date and time, and other details of the oral examination.

## 5. Notification of Selection Results

Letter of Acceptance/Rejection of Application will also be sent by post to each applicant.

## 6. Enrollment Procedures

Successful applicants will be notified of enrollment procedures by post in the beginning of March 2022.

(1) Registration Date: Scheduled for Friday, March 18, 2022 (Scheduled)

(2) Venue of Registration: Successful applicants must register in person at the Office of Student Affairs, Graduate School of Environmental Studies.

## 7. Registration and Tuition Fees

(1) Registration Fee: JPY 282,000 (estimated)

\*To be paid by the date of registration stated above.

(2) Tuition Fees: JPY 267,900 (estimated) per semester

\*To be paid on a per semester basis. Tuition fees for the Spring Semester are to be paid in May (in April from the second year onwards), and those for the Fall Semester in October. In the event of a revision in the tuition fees, the new fees will be applied as effective from the date of revision.

Note: Registration and tuition fees are exempted for students receiving the Japanese Government (MEXT) Scholarship.

## II. DOCTORAL DEGREE PROGRAM

### 1. Eligibility Requirements

Applicants must meet one of the requirements listed below:

- (1) Completion, or expected completion by March 31, 2022 of a Master’s Degree from a graduate school in Japan.
- (2) Completion, or expected completion by March 31, 2022 of graduate study at a graduate school in his/her home country or other countries. The qualification awarded must be recognized as the equivalent of a Master’s Degree in Japan.
- (3) Approved by the Minister of Education, Culture, Sports, Science and Technology of Japan (MEXT) (1989 Ministry Bulletin, Vol. 118).
- (4) Completion of a program of study recognized by the Graduate School of Environmental Studies as equivalent to the completion of a Master’s Degree program from a Japanese university.

A separate application is required for the eligibility examination, to be submitted by June 9, 2021.**

### 3. Application Procedures

Applicants must prepare the following documents and submit them by registered mail to: The Office of Student Affairs, Graduate School of Environmental Studies, Nagoya University, D2-1(510), Furo-cho, Chikusa-ku, Nagoya 464-8601, Japan.

The application documents must reach the Office of Student Affairs between July 5 and 4:00 p.m. July 9, 2021. All application documents shall be filled out in either Japanese or English.

The application fee must be paid through the information terminal at the convenience store in Japan, following the directions in Appendix 1. Only overseas applicants are allowed to make payment by credit card, UnionPay, and Alipay. Applicants must complete the payment process on the website (<https://e-shiharai.net/english/>) by July 8, 2021, before submitting the application documents. Please refer to Appendix 2 for payment procedures in detail.

Applicants must submit an original score sheet of the "Test Taker Score Report" of TOEFL (iBT), the "Official Score Certificate" of TOEIC (Listening & Reading test), or the "Test Report Form" of IELTS (Academic Module). Only scores of the examinations taken on or after August 1, 2019, will be accepted. The original score sheet will not be returned. For more details, please refer to the "4. Examination Method". In case of the Architecture course in the Department of Environmental Engineering and Architecture, however, applicants whose first language is English are exempted from submitting the original score sheets of TOEFL/TOEIC/IELTS,
- (10) Master's Thesis/Research Paper  
Applicants for the Division of Hydrospheric-Atmospheric Sciences can submit any one from among (i) Master's degree thesis or it's abstract (if it has not been submitted, what you plan to submit), (ii) reprints of journal articles, and (iii) photocopies of proceedings of an international meeting.
- (11) Additional Application Form (required only for applicants to the Division of Hydrospheric-Atmospheric Sciences in the Department of Earth and Environmental Sciences)

There are no other formatting requirements. Note that it must be original and unpublished.
- (13) List of publications, awards and achievements (only for applicants to the Sustainable Development Course in the Department of Environmental Engineering and Architecture)  
International applicants to the Sustainable Development Course in the Department of Environmental

Engineering and Architecture must submit a list of publications, awards and achievements as part of their application. Prepare and print the document on single-sided A4 paper. There are no other specific formatting or page requirements. If there are no applicable items, submit a paper noting this.

(14) A photocopy of your residence card

Those applicants who are currently residing in Japan must submit a photocopy of their residence card (both sides).

(15) Applicants receiving a scholarship from the Japanese Government (MEXT) must provide a Certificate of Status issued by the university where they are currently enrolled. However, the applicant who is presently enrolled in Nagoya University does not need to do it.

## 4. Examination Method

### (1) Department of Earth and Environmental Sciences (Division of Hydrospheric-Atmospheric Sciences)

The Department of Earth and Environmental Sciences consists of the Division of Earth and Planetary Sciences and the Division of Hydrospheric-Atmospheric Sciences. The Division of Earth and Planetary Sciences consists of the following seven laboratories: Earth Environmental Systems, Geology and Geobiology, Geochemistry and Cosmochemistry, Earth and Planetary Physics, Ecology, Earth and Planetary Dynamics, and Chronology and Natural History, and Ecology. The Division of Hydrospheric-Atmospheric Sciences consists of the following four laboratories: Global Environmental Variation, Climate Science, Global Geochemistry, and Global Water Cycle. The Division offering Doctoral Programs on this occasion is the Division of Hydrospheric-Atmospheric Sciences only.

Applicants are required to contact their prospective supervisor(s) prior to application, so that the supervisor(s) can prepare for the examination, taking the applicants' language ability and academic background into consideration. Depending on the Guidelines for Activities at Nagoya University During the Novel Coronavirus (COVID-19) Pandemic, the oral examination may be conducted remotely (online). Furthermore, online examinations may be held at times other than those listed below.

- 1) Applicants should arrive 10 minutes prior to the start of the examination and wait until called.
- 2) A whiteboard and a PC projector can be used for the presentation. A Windows PC with Microsoft Power Point (2016, Japanese version) will be provided.
- 3) The oral examination will be conducted in English and/or Japanese.
- 4) Applicants who are enrolled in the Master's program of the Division of Hydrospheric-Atmospheric Sciences, Department of Earth and Environmental Sciences at Nagoya University will be asked to give a 10-minute presentation on their Doctoral program research plan. This will be followed by an interview based on the presentation.
- 5) Other applicants will be asked to give a 30-minute presentation on their Master's program research (20 minutes) and their Doctoral program research plan (10 minutes). This will be followed by an interview based on the presentation.
- 6) Applicants are required to sit for the exam at the Environmental Studies Hall at Nagoya University. If it is difficult to come to Nagoya University, a remote (online) examination can be selected. Applicants who wish to take the examination online should fill out and submit the Additional Application Form (Division of Hydrospheric-Atmospheric Sciences). Applicants who wish to take the examination online will be notified of the examination schedule when the exam voucher is sent.
