【Immediately after employment】

Our group is working to clarify the role of atmospheric aerosols in climate change on the timescale from preindustrial time to the future. This position is open to a researcher who will study atmospheric aerosols and their interactions with radiation and cloud processes over oceans through improvement and simulations of our global aerosol-climate model.

The research topics will be discussed with the applicant, taking into account the applicant's skills and interests.
